BREAKING RULES vied outside, stretch duel, determined drive clear wire. FORTES vied inside, stretch duel gave in grudgingly under the wire. CONTROLLED TEMPER stalked the vying leaders three wide, in range upper, along third. PEACE FIRE tracked inside to far turn, bid off the rail upper, evenly lane. MAGGIE chased the pace four deep to far turn, came up empty late. TIMEISGOLDEN lacked speed leaving first turn, never factored. SHERIFF'S KID very slow start, lacked speed to far turn, never fired. MO TRAFFIC chased mid pack down the backside, weakened. SPECIAL NOTE slow into stride, never threatened.
